

### The Speonk Train Station by Dave Morrison

A small cafe was recently opened inside the old 1901 Speonk Station building. This is a wooden structure with a wraparound roof overhang. Another similar station building existed at Blue Point; erected in 1900 and demolished in 1951. That station stop was eliminated from the timetable in 1980. According to the late LIRR historian Ron Ziel, "the Speonk and Blue Point buildings were delightful aberrations from the usual design of LIRR station buildings."



The photograph at top is a 1907 view of the structure, showing the LONG ISLAND EXPRESS sign on the left side of the building.

The bottom left photograph was taken by LIRR Claims Department photographer Fred J. Weber on January 13, 1949. Viewed looking west, a trainman is in front of the building with a passenger train at the platform. Look closely and you'll see the scalloped roof support brackets attached to the posts.

The new cafe, known as the **Little Gull Cafe**, was established by Chef Will Pendergast, who is seen with his family in this recent photograph taken by Kitty Merrill. # THIS MONTH'S FEATURE: THE NEW HAVEN RAILROAD'S "STATE OF MAINE PRODUCTS" 40-FOOT PLUGDOOR BOXCAR IN RED, WHITE AND BLUE

First of all, I wish everyone a Happy New Year and a healthy one, too!

Every once in a while, I strike gold and when I went to my local hobby shop in Hyannis not too long ago—it's Centerline Hobbies—I picked up a really cool boxcar kit that apparently came in from an estate sale and was never assembled. The car and kit was a boxcar, a 40-foot insulated plugdoor boxcar manufactured by Intermountain Railway company and yes, this company made kits before they concentrated on read-to-run rolling stock.

The car was a specialty item and had no number, but was simply known by its road number, #45074. The car, was owned by the New Haven Railroad and was painted in the BAR and NH railroads' popular and colorful red, white and blue "State of Maine Products" paint scheme. The car was apparently produced by Intermountain for Branford Hobbies in Branford, Connecticut at 609 West Main. I attempted to contact them in regards to the history of this car but no one ever got back to me; I was very curious about the history behind this kit.



Anyway, when I saw the label, I just knew I had to have this car so I bought it. I brought it home and realized I had a good amount of information on the "State of Maine Products" cars as owned by both the New Haven and Bangor and Aroostook Railroads. They had been written up by several modelers and the articles on them were quite informative.

These cars, with their red, white and blue-stripes, blue ends and roof made for a most colorful car and was probably one of the most attractive paint schemes ever introduced on a boxcar. Note mentioning is the blue on the car sides does not match the blue ends of roof of these cars. Still, it was an attractive paint scheme and I knew I was happy to have this car on my freight roster. Since I didn't know much about these cars, I thought I would read all about the cars before I assembled it.

For many years Maine had a robust potato business and it moved by rail. The top potato hauler was, of course, the Bangor & Aroostook Railroad. The potato-shipping season was September trough June each year and March was the peak month. From September 1949 through June 1950, almost 47,000 carloads of potatoes originated for hauling and 86% of them road the BAR.

Potatoes were usually shipped in refrigerator cars but in 1950 the BAR had Pacific Car & Foundry build 300 insulated 40-foot boxcars with plugdoors and the red, white and blue stripes that ran the length of the cars with large billboard lettering.

Each car was equipped with a Luminator-Mitchell #14 charcoal heater suspended from the car floor. More about this later in my feature.

In 1953 the BAR had another 150 cars built. In addition to these insulated boxcars, the BAR had 1200 refrigerator cars and this was the second-largest railroad-owned fleet of cars for fresh produce service; Santa Fe Railway had the largest fleet at that time with about 14,000 refrigerator cars.

This same year—1953—the New Haven Railroad had a fleet of 100 similar cars built. The New Haven car is the one I will construct. More about this car next time.

#### LIRR News by Steve Quigley

On 1/2/2022, the LIRR commenced work on the Denton Avenue Bridge which goes over Denton Avenue in Garden City Park and Tanners Pond Road in Garden City. The Village of Garden City granted the work permits that the LIRR and MTA had sought for almost 1 year. The delay in the construction of the bridge which is a small single lane tunnel could delay the completion of the 3rd Track Project and could potentially cause the \$2.6 billion project to go over budget. In December, the LIRR persuaded a NY State Supreme Court justice to compel the Village to grant the needed work permits. Even after losing the appeal, the Village refused to do so. On December 22nd, the LIRR asked the court to hold the Village in contempt! On December 31st, the Village granted the requested permits. Since the village granted the permits, the contempt suit has been dropped.

It is unknown if the tunnel will be for one way traffic or if there will be traffic signals on each side to permit two way traffic through a single lane wide tunnel. Informed sources have told me that the Village does not want traffic signals and that the one way designation can later be made two ways as it is a Village road. It remains to be seen if the bridge work will be completed in time for the grand opening of the East Side Access project but if history repeats itself, the work on the 3rd Track Project will be completed just in time for the ESA Grand Opening!

On Monday, 1/2/2022, the LIRR restored 15 trains to its schedule that had been cut for most of the pandemic. With these added trains, the LIRR is running between 20% to 23% less peak trains than before the pandemic. The railroad is averaging between 52% and 55% of its 2019 monthly weekday and weekend ridership. As of the beginning of December 2021, the LIRR on time performance was 96.2%. This percentage represents the trains that arrive at their final destination within 5 minutes and 59 seconds of their scheduled arrival time. It is planned that the LIRR will return to peak rate ticket fares on 3/1/2022. The ticket charge prices are as follows: When purchased through eTix, a new 20 trip ticket will offer 20% off the comparable 20 peak fares. Monthly tickets which are currently discounted between 48% and 61% off one way peak tickets will be discounted by an additional 10%. "City Ticket," which is for travel within NYC on weekends, will be extended to all weekday off peak trains at a fare of \$5.

The LIRR has started to rollout Help Points to additional stations. The intercoms, which can connect passengers to emergency services or general travel information, were first piloted by the MTA on the subway system. The MTA has allocated \$5 million in its 2020-2024 Capital Program to bring Help Points to all LIRR stations. The LIRR has been experimenting with a new design that includes an additional button and yellow flashing beacon for passengers who need boarding assistance. It is currently projected that a system wide rollout of Help Points to all LIRR stations to be completed by December 2024.

### Third Track Expansion Project by Dave Morrison

A new station building was dedicated at Mineola on September 22, 1923. This two-story, gambrel-roofed building, on the north side of the tracks, had an upstairs living quarters for the station agent and family. On

the south side of the tracks, opposite the new building, a substantial waiting room building was opened to serve eastbound passengers. The 1935 photograph at right shows an eastbound passenger train, hauled by steam locomotive No. 29, heading through the station area. The eastbound waiting room building is at the left side of this photograph.

As part of the LIRR Third Track Project, the eastbound waiting room building was demolished due to the fact that it was in the path of the new third track. Two photographs below, taken from the roof of the Mineola Boulevard parking garage, show the progress being made on the project. The January 17,



2021 photograph (left) shows the cleared pathway for the installation of the new track. The foundations for a new pedestrian overpass, east of the station building is evident in this photograph. In another photograph, taken about a year later, on January 3, 2022 (right), the progress on the new overpass can be seen. Progress has probably been slow because there was a serious accident on March 13, 2021 when the center span for the overpass was being installed.

The good news is that the station building is going to be preserved and renovated. Next year, 2023, will mark the 100th Anniversary of Mineola Station. That should be quite a celebration!
